Autumn/Winter Programme for Forum

Dear Co-ordinator/Delegation Secretary

Over recent weeks, my colleagues in the Secretariat have consulted Forum delegations on the Autumn/Winter programme for the Forum, on the basis of a paper setting out a draft outline of such a programme for both plenary sessions and sub-committees which had been prepared by the Chairperson, myself and Secretariat colleagues in the light of the Co-ordinating Committee decisions on 7 July, the plenary debate that day on a review of the Forum's work, further responses to our review documents (F244 and F248) and our general knowledge of delegations' concerns. We in the Secretariat have followed up on the points made to my colleagues in the course of the recent consultations and I now enclose a paper (F257), setting out our proposals for the Autumn/Winter programme.

We are proposing a meeting of the Co-ordinating Committee in Dublin Castle at 7 p.m. on 28 September to take stock in terms of the details of the programme but it will be necessary, for planning purposes, that we obtain reactions to this programme from delegations before that. Accordingly, we shall contact Co-ordinators by telephone next week. On the basis of the consultations already undertaken, it appears that there is already agreement as to the business for the first three Plenary Sessions.

On 22nd September it is proposed to hold the meeting of the Economic Sub-Committee at 11.30 and that of the Sub-Committee on Obstacles in the South to Reconciliation at 2.30. Lunch will be provided at 1 p.m. for members of both sub-Committees. If delegations wish to nominate two representatives to attend the Economic Sub-Committees, they may do so. This would also apply to the Sub-Committee on Fundamental Rights whose first meeting is now fixed for 29 September, to allow time for Dr. Eide to supply a revised draft of his study. In addition, if, on plenary session days, other Forum members wish to attend at these Sub-Committees, this is acceptable, subject to any physical limitations on any particular day.

The meeting on 29 September of the Sub-Committee on Fundamental Rights will take place at 2.15 p.m.

My colleagues and I are at the disposal of delegations to respond to any queries they may have.



I hope that all of you have had some opportunity for relaxation since the summer break, to refresh and renew your energies and creativity and that we may all look forward to a productive Autumn/Winter session of the Forum.

Autumn/Winter Programme for Forum for Peace and Reconciliation

Frequency and Pattern of Meetings - Plenary Sessions on two Fridays out of every three.

The Record of the meeting of the Co-ordinating Committee on 7 July, 1995 (F251/CC) notes:

"In regard to the programme of work for the early Autumn, it was agreed that there should be a strong focus on results, with priority attention to the work of the Drafting Committee and to agreeing, initially in sub-Committees, Forum conclusions on various consultancy studies. It was noted that this might call for some all-day private meetings and thus that plenary public sessions might be reduced, with flexibility, to once a fortnight".

Consultations with delegations in recent weeks revealed concerns on the part of a number that, particularly in the context of the situation in the wider peace process, any marked reduction in the rhythm of public Forum meetings might

- (1) deprive delegations of valuable and necessary opportunities for regular contact and
- (2) send the wrong political message to the general public and to other actors in the peace process.

Accordingly, the Chairperson and Secretariat have taken soundings on the acceptability of a pattern whereby plenary sessions would be held on two Fridays out of every three. There is widespread support for this and planning has therefore proceeded on this basis.

Contacts with delegations also suggest that it may be more convenient for members of the <u>Drafting Committee</u> if its meetings are, as hitherto, held on the same day as Plenary Sessions, rather than on days where there is no Plenary Session. It is proposed therefore to hold such meetings at 9 a.m. on days when there are Plenary Sessions.

It will be necessary to continue to hold meetings of the <u>Co-ordinating Committee</u> but, probably, at a lesser frequency than over most of the period up to the summer break. In view of the pressure on other time slots, it is proposed to hold such meetings, as necessary, either over lunch on days of Plenary Sessions or, where this is not possible and in view of the considerable overlap between the Co-ordinating and Drafting Committees, by assigning some time at the latter to Co-ordinating Committee business.

It is proposed to ensure that as between the Drafting Committee and the three Sub-Committees - on Obstacles in the South to Reconciliation, Fundamental Rights and Economic Matters, there will not be more than 2 such committees meeting on the same day.

Thrust and Balance of Programme

A possible draft calendar to the end of 1995, for both Plenary Sessions and for sub-Committees is presented below, followed by some detailed notes and a grid of Plenary and sub-Committee meetings is annexed. These assume that developments in regard to the wider peace process and all-party talks would be such that the Forum would continue to hold plenary sessions to the end of the year according to the pattern set out above.

The thrust and balance of the programme aims to respect the guideline set at the Co-ordinating Committee on 7 July (as set out above), while taking into account as far as possible and striking a balance between the views expressed by delegations in consultations on the programme over recent weeks.

Thus the programme as a whole, including for sub-committees, has a strong focus on (a) the work in the 'Drafting Committee and (b) on reaching results and publishing Forum outputs in regard to the areas covered by consultancy studies and other sub-committees. All of this work will, however, proceed in private session and in order to sustain public interest and the profile of the Forum, it will be necessary to continue with Plenary Sessions dealing with other matters, that are of intrinsic importance in the light of the Terms of Reference and that will have public impact.

A very probable address by Vice-President F.W. De Klerk of South Africa and a possible address by President Clinton would have such impact, as would the confirmed oral presentation by the Roma. Catholic Church after the divorce referendum. If certain possibilities being explored as to oral presentations from a unionist perspective were realised, they would also attract strong public interest.

There is now wider acceptance among delegations of a visit to Belfast by a Forum panel but there is continuing caution and concern about timing, having regard to the unpredictability of events. Many delegations, notably those that are now or were in the recent past in Government in the South, also recognise the need to ensure that any such visit is widely accepted as conforming to paragraph 11 of the Joint Declaration. Subject to this, the proposal is that a Forum panel (the size and composition of which would be for decision) would visit Belfast to hear Oral Presentations at a neutral venue, the presentations to be related to submissions received and to be balanced as between those from nationalist, unionist and other perspectives. The arrangement would be made with presenters, on the basis that if consideration of timing so imposed - by reference to wider political events - the session could be changed to Dublin at short notice.

Public Hearings on Education and Sport that were deferred from the pre-summer session are included. These also feed into the work of the Sub-Committee on Obstacles in the South to Reconciliation and the dates proposed for them reflect this.

The consideration of draft Forum commentaries on a number of consultancy studies in the economic and human rights areas provides opportunities for the Forum to revisit major subthemes, the Social and Economic Consequences of Peace and Parity of Esteem/Equality of Treatment and to hold round-up debates on these. It would be for decision whether these commentaries, together with the Realities/Principles document and the Obstacles Report, would be published under one cover (as a "Forum Report") or separately - or both.

Notes on Plenary Session Programme

- One major body with a unionist perceptive is to take its decision shortly as to whether or 1. not to make an Oral Presentation to the Forum.
- In regard to an earlier tentative idea for a Public Hearing on 27 October on the theme of 2. Conflict Resolution, to cover the South African and Middle East perspectives, it has emerged from contacts with the South African and Israeli authorities that it would not be possible to arrange for relevant personnel to come for a session as early as 27 October. It has also emerged that the programme for an 11 October visit to London by Mr. Cyril Ramaphosa is too overloaded to permit his travelling on to the Forum at that time. However, it has been arranged, subject to full confirmation, that Vice-President F.W. De Klerk of South Africa will address a special session of the Forum on the morning of Tuesday, 21 November.
- The question of President Clinton addressing the Forum during his visit to Ireland has 3. been raised with the Irish and U.S. authorities involved in preparing the visit. Reactions to the principle have been positive but it is clear that there are many competing calls on

time within what seems likely to be a tightly restricted time framework.

- 4. Contacts have been reopened with the Sports Council of Northern Ireland but even if they do not participate, the intention would be to proceed with the Public Hearing on Sport, with the participation of the Sports Council in the South and of prominent people in the sports world, North and South, to be approached directly.
- 5. In correspondence between the Chairperson and Cardinal Cahal Daly, it has been fully confirmed that the Roman Catholic Church will be very happy to make an oral presentation and will be ready to do so in December.

Drafting Committee

- 1. First meeting on 29 September at 9 a.m.
- 2. The schedule proposed in the annexed grid would mean a total of seven meetings in the period to Christmas. It would, of course, be up to the Committee itself to decide the pace at which it wished to move towards completion of a document and additional meetings (of day-long duration, if required) could be convened, if this was felt necessary.
- Secretariat will circulate revised Realities Draft and first Draft of Proposed Principles around 20/22 September.
- As indicated, recent consultation with delegations indicate broad support for maintaining a pattern of meetings at 9 a.m. on days of Plenary Sessions.

Co-ordinating Committee

- As indicated, there is an ongoing need for the Co-ordinating Committee to maintain overall oversight of the work of the Forum. In regard to its first meeting which will need to take stock of the details of the Autumn Programme of Work it is suggested that this might usefully take place on the evening of 28 September (the day before the first Plenary the usual 9 am slot on Plenary day itself is ear-marked for the Drafting Committee). Perhaps 7 pm would be a suitable time.
- 2. One of the early decisions which the Co-ordinating Committee will have to make is how the issue of public submissions is to be handled in the Autumn. A number of submissions on the short list drawn up by the Sifting Committee have not yet made been heard orally. How many of these should be called? Moreover, some 30 further submissions have been received since the Sifting Committee last met. Should that Committee be reconvened to consider these?

- 3. It this approach is accepted, the aim might be to publish (a) the Eide Study in mid-October, (b) the Boyle/Hadden/Campbell in mid-November and (c) the Forum conclusions on both in mid-December
