The draft Declaration has been drown up in comultation with Mr Hume, Leader of the SDLP, using language from previous communiquels and Agreement, from speeches by the Secretary of State, and from the Report of the New Ireland Forum. It is, the Trainseach is authoritatively informed, acceptable to both Sinn Fein and the IRA as a basis for an alternative political strategy for peace, which will involve a lasting censation of violence.

The draft Declaration is fully consistent with the international obligations of both Governments and with the terms of Article 1c of the Angio-Irish Agreement. Indeed, the acceptance by the entire Irish Nationalist tradition of the retailing of the need for consent as an essential practical prerequisite to the establishment of a united freland represents potentially a profound and binstric Infill. The duft Declaration would involve the British Government, taking a flowurable view of a united Irelanda as a destrable long-term goal, procided that sufficient agreement and consent were fortherming. This was the position of the British Government at the time of the Government of Ireland Act, 1950, and the Anglo-Irah Treasy in 1921.
