As you and your Secretary of State lied about your communications with the IRA men of blood, so you have deceived the Ulster people in your talks with Dublin.

The declaration which you and Albert Reynolds sign and make public today, is not between you and him alone. It is a tripartite agreement - Reynolds, the IRA and you.

You have sold Ulster to buy off the fiendish republican scum, and you are prepared to do this notorious deed with such speed that time is not even given for the Christian burial of their latest victim - a gallant member of the RUC.

You will learn in a bitter school that all appeasement of these monsters is self-destructive. The hand which reaches for your blood-money will never be satisfied until it destroys you.

In the name of the law-abiding Unionist majority population of Ulster, who have put their faith in, and given their loyalty to, this United Kingdom in its times of crisis, WE PROTEST!

You have consulted Dublin; you have not consulted them. You have freely given the Prime Minister of a foreign and alien power joint jurisdiction with yourself over part of Her Majesty's dominions.

You have wrapped up your deal in words prompted by Reynolds but their origin is the mouth of the IRA.

You have utterly failed in what you said you would do in getting rid of Articles Two and Three of the Irish Republic's Constitution, and their illegal, immoral and criminal claim over the territory of Northern Ireland. Instead, you want the Ulster people to take in trust the promise of the Dublin liar that if an overall package is agreed with the proper constitutional balance, the Articles will be removed.

The self-determination you offer the Ulster people is the self-determination of a chained slave, and the consent you offer them is the consent of a battered child.





No doubt you will be lauded as a great statesman, and all sorts of congratulatory speeches will gladden your heart and boost your pride, but the blood of the righteous dead and the cries of the widows and orphans have a voice that rises higher than them all, to the God who neither slumbers nor sleeps, and who will in no wise clear the guilty.

To that faithful God we commit our cause in this dark hour of your treachery.
