#### THE NORTHERN IRELAND LEGISLATIVE PROGRAMME

It is a custom (that I have agreed to continue) that at the start of each Parliamentary term Northern Ireland parties and Opposition spokespersons at Westminster receive a copy of the Government's intended legislative programme for Northern Ireland.

It now seems to that it would be appropriate for the smaller parties involved in the Talks but not represented at Westminster to also be aware of forthcoming legislation. I therefore attach an Annex detailing progress expected on 3 Northern Ireland Bills currently before the House and those Orders in Council that are likely to come forward up until the Summer recess.

The Annex also gives details of those Orders in Council that have completed their parliamentary stages in the pre-Christmas term, those we plan to bring forward in the current session and those Proposals for draft Orders in Council



we intend to publish in the course of the summer along with details of negative resolutions for Northern Ireland which will stem from GB Bills.

If, as I hope they will, the talks produce a comprehensive negotiated outcome by May, we can also anticipate a need for urgent legislation to conduct a referendum.

I am writing in similar terms to each of the four parties involved in the talks but without representation at Westminster.

NORTHERN IRELAND BILLS

1. **Police (Northern Ireland) Bill**

Purpose

To increase the accountability and effectiveness of the RUC and Police Authority in line with the Government's May 1996 proposals and the recommendations in the Hayes Report on reforming police complaints procedures.

Parliamentary Stages - Easter Term

The Police (Northern Ireland) Bill is likely to go into Committee stage at the beginning of February. The Committee Stage is likely to last 6-8 weeks. Commons Report Stage may take place before Easter depending on a number of factors.

2. **Public Processions etc (Northern Ireland) Bill**

Purpose

To amend the law of Northern Ireland relating to public processions by implementing recommendations contained in the North Report presented to the Secretary of State in January 1997.

Parliamentary Stages - Easter Term

The Public Processions (Northern Ireland) Bill is due to go into Committee in the House of commons on 15 January. It is expected to be ready for Royal Assent at the beginning of February.

3. **Northern Ireland (Emergency Provisions) Bill**

Purpose

To extend the life of the existing Northern Ireland (Emergency Provisions) Act 1996, with amendments.

Parliamentary Stages - Easter Term

Scheduled to receive Second Reading in House of Lords on 12 January. bill should be enacted in good time, perhaps even before the Easter recess. As this bill makes provision for the 1998 renewal

requirements to be waived, if the Bill is enacted before 15 June 1998, the next EPA renewal debates will be in June 1999.

**Housing (NI) Order** - To amend the legislation governing Housing Council nominations to the Northern Ireland Housing Executive Board and introduce new rights for NIHE tenants to have repairs carried out and receive compensation for improvements which they have made to their homes. To extend the NIHE's vesting powers to enable it to acquire land for improving the amenities of a housing area and introduce a form of qualifying shorthold tenancy for housing associations. It will also include provisions for making the Private Sector Grants Scheme largely discretionary, provide for new duties to persons accepted as homeless, introduce additional grounds for re-possession and obtaining injunctions in cases of anti-social neighbours.
