

Thank you for your letter of 2 November. I look forward very much to receiving your submission on the Review under Article 11 of the Agreement.

You asked for a statement on the subjects raised at the Conference over the past three years. Details are given in the joint statements issued after each meeting. You may well have a set of these already to hand, but in case you do not, I enclose one, along with a table of meetings, and their locations (which I gave in reply to a Parliamentary Question from Harold McCusker recently).

As for the Secretariat, its function is that set out in Article 3 of the Agreement: "servicing the Conference on a continuing basis in the discharge of its functions as set out in this Agreement". Apart from work directly in connection with meetings of the Conference and its subgroups, such as fixing dates, discussing agendas, and preparing notes, the Secretariat has also developed as the channel of confidential communication, on matters within the scope of the Agreement, from one side of the Conference to the other, between meetings; business of this sort, in fact, takes up a large part of



its time. Obviously I cannot make public details of all these exchanges, any more than we normally publish comprehensive records of diplomatic exchanges: no subjects are handled which are not proper to the Conference.

The work of our side of the Secretariat is discharged by three officials, along with support staff. Without wishing to be unhelpful, I think it is for the Irish Government to answer about its own arrangements.
