FORUM FOR PEACE AND RECONCILIATION

Review and Forward Planning of Programme of Work of Forum

Previous decision of Forum

- 1. At its meeting on 18 November, 1994, the Forum approved the Secretariat's paper Possible Programme of Work to end-February (F005 Rev. 1). A possible calendar was included in this paper but it was explicitly stated that this remained very much a tentative outline, subject to any adjustment that might be necessary.
- 2. The Forum has, broadly, followed the programme of work, as approved. However, the discussion on the Nature of the Problem etc. has taken considerably longer than originally envisaged, while the Forum is also well behind the planned schedule in dealing with the various sub-themes. Originally, the initial discussions of these were to be completed by 13 January, whereas only two, Economic and Social Consequences of Peace and Parity of Esteem have been dealt with, even by the Co-ordinating Committee. Discussion of the Nature of the Problem was to have been completed by 9 December but will not now be finished until 3 February.
- 3. As a result of political developments in the South, some time has also elapsed in the wider political and inter-governmental arena in and affecting Northern Ireland. This may mitigate any loss of time in the Forum's planned schedule.

Review of Programme

- 4. In reviewing and adjusting the planned programme, a number of considerations have to be taken into account, which may be, in part, opposed to one another:
 - (1) it is necessary to bring initial discussion of the Nature of the Problem etc. to an early conclusion;
 - (2) it is desirable not to allow much more time to pass before holding public sessions dealing with submissions to the Forum, so as not to appear unresponsive to the over 300 groups and persons that have made submissions.
 - (3) it is necessary to put further work on sub-themes, particularly any work to be commissioned, in hand without undue delay.
 - (4) the Forum will wish to accommodate distinguished visitors, such as Senator George Mitchell, the U.S. Co-ordinator who wishes to come on 17 February.

- (5) the Forum will wish to set aside sessions to hear presentations on Agriculture (joint submission promised by IFA/UFU), Tourism and Trade (omitted from 16 December hearing) and Education and Youth (requested by a number of delegations).
- (6) it will be necessary for the Forum to consider how it wishes to handle the Framework Document when it is published.
- 5. On a rough assessment that about 10% of submissions may warrant public sessions for presentations/questioning, about 30-40 groups or individuals could be involved. On experience in the New Ireland Forum and in this Forum to date, it would not be possible to deal with more than 4-5 in a full day. This implies 6-10 days. On this basis, it does not appear sensible to deal with all submissions in one block; and it would scarcely be possible, consistent with other imperatives, to devote full days to them, as a general rule. It may be preferable to allocate half-days to them, with the remaining halves being devoted to other Forum business.
- 6. On this basis a possible programme and calender of work to May, 1995 is attached to this note, for the consideration of the Co-ordination Committee. As before, this is tentative and must remain subject to adjustment. In particular, and self-evidently, the scheduling of the Forum's consideration of the Framework Document assuming that its publication takes place during this period will have knock-on effects on the programme and calender.
